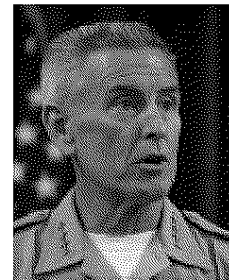
Further impacting, in community affairs in total, our digital footprints taken to prejudice our validity in society, continued stigma goes beyond the dating and social friend circles.
